## **Executive Directors' Report (6:51pm)**

Jay Cerny provided several updates regarding Vanguard Classical School

- He mentioned, most parents want to return to in person 2021-2022 school year. So, Vanguard will only have in person option in 2021-2022. Plans have been created in case of a quarantine
- The APS board approved 5 year renewal
- 75% of families are back to in person but schools are still maintaining a 3ft distancing for now. There's been limited COVID spread with kids as it seems to be present more often in adults
- Vanguard will follow APS decision on vaccines.
- All board members are invited to attend graduation ceremonies

## Finance Committee (7:03pm)

The 2021 Fiscal Audit (\$8,400) action item was presented. A motion to approve was raised by Director Secor and seconded by Director Jorgensen; the item was approved unanimously.

An overview of finances was provided. No questions regarding the April register were raised.

In addition, benchmarks continue to be consistent with prior months. The fund balance is \$2,997,001 with income being at 83% and revenues reflecting 73% of revised budget. Total expenditures are at 73% of the revised budget.
