The meeting was called to order at 4:33 PM by Board Chair, Judith Ham. The pledge of allegiance and roll call took place.

BOARD PRESIDENT REPORT

Lisa Sagaser talked about the new Board Member candidate, Dr. Robert Fulton. The Board discussed his credentials and plan to have him appointed at the October meeting.

The Board Chair shared an update on the ED search and discussed the candidate would be on-site Friday, September 28 to tour the campus locations and meet the admin teams. The discussion also included the details of the Sunshine Law and that the final candidate would be posted for 14 days before any official offer could be made; the community would have the opportunity to meet the candidate during the 14 day period. Angle Keedy asked for confirmation that the ED position would be a VCS employee and not ACCO.

FINANCIAL REPORT

Syed Ahmed and Angie Keedy discussed the early Mill Levy dollars and that a look at October enrollment would be the deciding factor in the need to make cuts if needed. The goal is to reduce line items, and it was discussed that over spending in one area would create a shortage in another area. Auditors are wrapping up their audit, and the auditor will present at the November Board Meeting. The Board discussed the financial policies & procedures that need to have Vanguard Classical School name on them, and the Board accepted them.

DIRECTOR'S REPORTS

Angie Keedy gave an update on the Charter Renewal; she discussed the process and timeline and shared she is actively talking with people at the Office of Autonomous Schools (OAS) to ensure all the application items are complete. Lisa Sagaser made a suggestion to post the completion timeline, and Danielle Tomwing asked about sharing specifics about the progress. Lisa Sagaser also asked if the site visits were part of the renewal, and Angie Keedy explained each area was addressed and resolved. Angie Keedy shared that there will be a presentation of VCS given to APS/OAS in November.

Italy School Trip 2021 – Angle Keedy shared details about the class trip, and asked teachers to share the process for organizing the trip and the logistics; the teachers provided rationale and how it aligns with the Classical Education Model. The Board voted on approving this trip. A motion to approve was made by Chris Jensen and seconded by Jack Robinson. Board members Jack Robinson, Chris Jensen, Lisa Sasager, and Danlelle Tomwing voted "Aye", and the motion carried unanimously.

OLD BUSINESS

Angie Keedy shared that there are good things happening and things to celebrate. She talked about the next steps with the Inclusion Task Force. The Board discussed the VCS Advisory Council process and structure; all Board Members agreed to approve and post the nomination form September 28, 2018, and sent through School Messenger. A recommendation was made to have the nomination form be translated to Spanish. A motion was made by Jack Robinson and seconded by Chris Jensen. Board members Jack Robinson, Chris Jensen, Lisa Sagaser and Danielle Tomwing voted "Aye", and the motion carried unanimously.

Lisa Sagaser read a letter from Sonja Herrera that explained her reasons for no longer being on the Board.

NEW BUSINESS

The Board discussed approving the public comment policy and procedures. There was a recommendation to have a timeline for response and placing an auto-reply message to the sender of an email (a timeline for urgent matters was also discussed). The Board discussed putting the policy in the auto-reply, and Bill Bethke suggested that public comment be reviewed by the Board and a summary provided in the minutes. A motion was made by Jack Robinson and seconded by Danielle Tomwing. Board members Jack Robinson, Chris Jensen, and Danielle Tomwing voted "Aye", and the motion carried unanimously.

Public comment included the topic areas of email requests, minutes to include summary of public comment, ED search, letters of reference and Board voting timeline.
